

CITY OF MELFORT
BYLAW NO. 2021-01

A BYLAW OF THE CITY OF MELFORT, PURSUANT TO SECTION 337 OF THE CITIES ACT, TO APPOINT BYLAW ENFORCEMENT OFFICERS TO ENFORCE THE BYLAWS OF THE CITY OF MELFORT

THE COUNCIL OF THE CITY OF MELFORT, IN OPEN MEETING ASSEMBLED, ENACTS AS FOLLOWS:

1.0 Interpretation

1. For the purpose of this bylaw, the expression:
 - 1.1 "Council" means the Council of the City of Melfort.
 - 1.2 "Municipality" means the City of Melfort.

2.0 Scope of Bylaw

- 2.1 The Council hereby appoints the persons listed on Appendix "A" as Bylaw Enforcement Officers for the Municipality.
- 2.2 The duties of the Bylaw Enforcement Officers shall be:
 - a) to enforce the bylaws of the City of Melfort, as listed on Appendix "A", or as they may be amended from time to time.
 - b) to represent the Municipality before a justice of the peace or provincial court judge in the prosecution of anyone who is charged with contravention of a bylaw.
 - c) and other duties as may be assigned by council or its delegate.
- 2.3 The appointments shall commence on the date of the final reading of this Bylaw or any amendments as may be made from time to time.

3.0 Application of This Bylaw

If a court of competent jurisdiction should declare any section or subsection of this Bylaw to be invalid, such section or subsection shall not be construed as having persuaded the Council to pass the remainder of the Bylaw, and it is hereby declared that the remainder of this Bylaw shall be valid and remain in force.

4.0 Coming Into Force

1. This Bylaw shall come into force and have effect from and after the date of the final reading.
2. Bylaw 2019-05 is hereby repealed.
