HELIPORT APPLICATION TO MINISTER OF HEALTH:

WHEREAS, as part of their mandate to support and promote municipal health interests in the region, the Municipal Health Advocacy Committee has been investigating options to enhance the delivery of health services at the Melfort Hospital, including the construction of a heliport, which is a critical component of the Committee's vision to improve and enhance the delivery of rural health services to the residents;

AND WHEREAS, in March, 2018, City Council authorized the Municipal Health Advocacy Committee to explore the construction of a heliport at the Melfort Hospital and seek endorsement from the Saskatchewan Health Authority;

AND WHEREAS, the Municipal Health Advocacy Committee is prepared to pursue financial and gift-in-kind commitments to fund 100% of the heliport project prior to commencement of construction;

BE IT RESOLVED that the Council of the City of Melfort approves the application to the Ministry of Health, as prepared by the Municipal Health Advocacy Committee and the Saskatchewan Health Authority, for the construction of a heliport at the Melfort Hospital. And further, once 100% of the funding is in place, the City agrees to be responsible for all capital construction, planning, design and associated construction costs for the project, the terms of which will be set out in an agreement between the City and the Saskatchewan Health Authority, to be ratified upon approval of the project by the Saskatchewan Health Authority and the Minister of Health. **Carried**
