WHEREAS in 2017 the Government of Canada passed legislation allowing RCMP members to unionize and bargin collectively, in June 2021 a tentative agreement was reached with negotiations taking place exclusively between the Federal Government and the Union for the RCMP.

AND WHEREAS the proposed new Collective Bargaining Agreement (CBA) which includes retroactive pay increases will have a significant financial impact on the City of Melfort and many other Saskatchewan communities.

THEREFORE, BE IT RESOLVED that a letter endorsed by SUMA on behalf of Council be sent to the Honorable Bill Blair - Minister of Public Safety to explain the hardships this decision will cause the City of Melfort and to request that backpay negotiated by the federal government be paid by the federal government.
